Criteria for evaluation and description on awarding points

Total Net price – lowest =6p (60%);

Points in regards to the "total net price" criteria will be awarded as following:

(lowest price in sample/ considered offer price) * 100 * 60%

Deadline for delivery and implementation – up to 12 months = 2p (20%);

Points in regards to the "deadline for delivery and implementation" will be awarded as following:

(2 p for the most favorable term/ 2 p for the most favorable term or 1 p second most favorable term or 0 p for further terms) * 100 * 20%

The most favorable period and warranty costs, software updates and remote support = 2 p (20%).

Points in regards to the "most favorable period and warranty costs, software updates and remote support" will be awarded as following:

(2 p for most favorable conditions in the criterion/ 2 p for most favorable conditions in the criterion or 1 point for most favorable conditions in the criterion or 0 p further conditions) * 100 * 20%
